Many signs are evident that the American goliath which has been dominating the 20th century is now starting to crumble. Signs range from social changes, economic changes and military changes. Generally, what we are finding is that the American empire is going the same way as the Soviet empire. It is an obsolete entity built with the same DNA as the Soviet Union desperately searching for a home. The old environment which it was used to, the stability of the Bi Polar communist Capitalist world is no more. With this 'Iron Curtain collapse' change which took place 20 years ago, the relevance and operational legacy of the American empire is no longer respected.

What has replaced it is a new order which is based around chaos. We are generally seeing old alliances and institutions being relegated to the dustbin of history with no justification. Suddenly, the whole world is different. 25% of these changes were seen when the Soviet model collapsed as it was economically the weaker of the two competitors; now we are about to witness the rest of the world adapting as the stranglehold of the West bears little resemblance to the way in which the world operates in the next 100 years. People are flocking to their past thinking, with cultures, religion and family unit forming a central bond into the way they see themselves in the future.
